

Cavan Grand Jury

The Grand Jury was a local government body originally concerned during the seventeenth century with the administration of justice. Later, its functions expanded to include the provision of roads and bridges and the maintenance of dispensaries, county infirmaries, lunatic asylums, courthouses and gaols.

Landowners made up the Grand Jury itself, selected by the Sheriff of the County. A tax was levied on the county or barony for the cost of road and bridge works and collectors appointed for the collection of these local taxes, known as the county cess. The Grand Jury met twice yearly at the spring and summer assizes for the purpose of passing presentments. These presentments constituted lists of proposed and approved works due to be undertaken and were financed by cess payers. Grand Jury archives have suffered serious loss in the past. From the 1890s almost all the archives of the Grand Juries were transferred to the Public Record Office of Ireland and were destroyed during the civil war in 1922. A small amount of material is now held by the National Archives and other material is held by County Archives Services. In the case of County Cavan, most of the surviving archives are presentment books listing details of monies paid to named persons for the upkeep of roads and bridges. Some Treasurer's material also survives.

The powers of Grand Juries were significantly diminished with the introduction of the Local Government (Ireland) Act, 1898 which established democratically

elected county and city representatives for the first time. The administrative powers and duties of the Grand Juries were transferred mainly to county councils and to a lesser extent to rural district councils by the 1898 Act.
